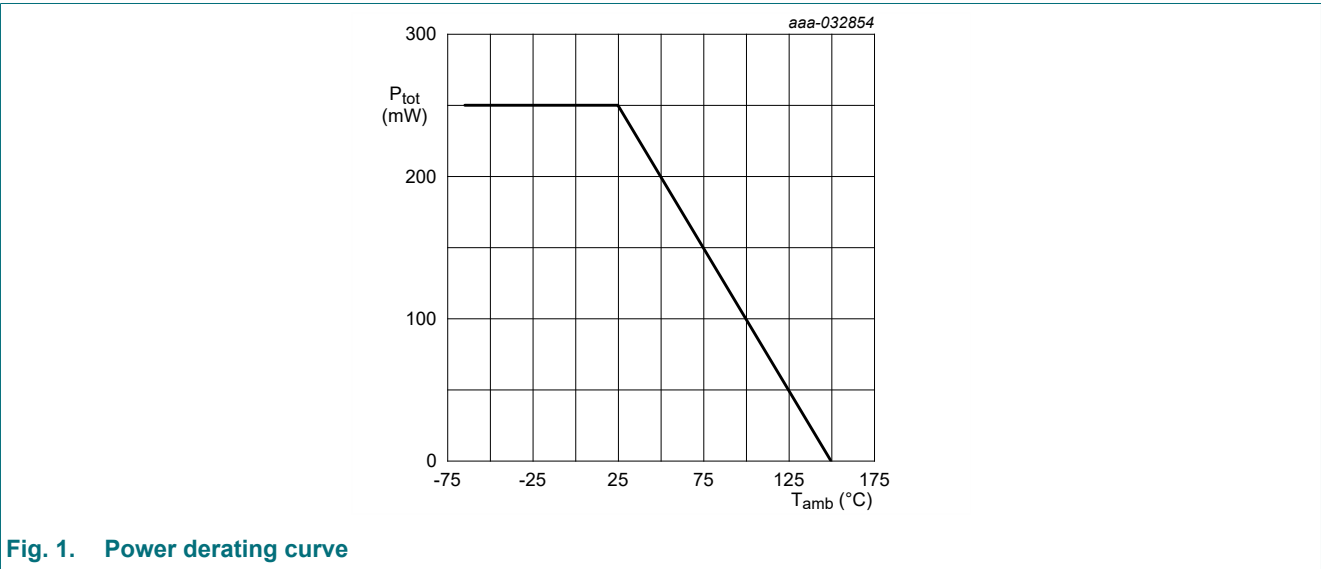


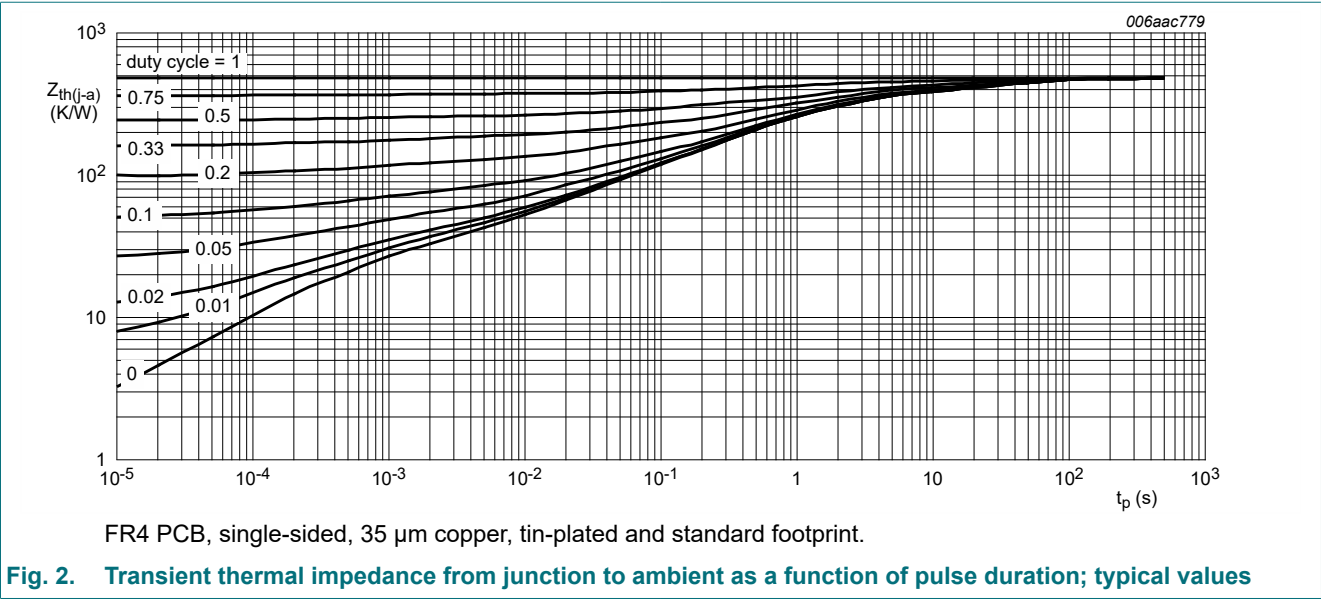
Fig. 1. Power derating curve

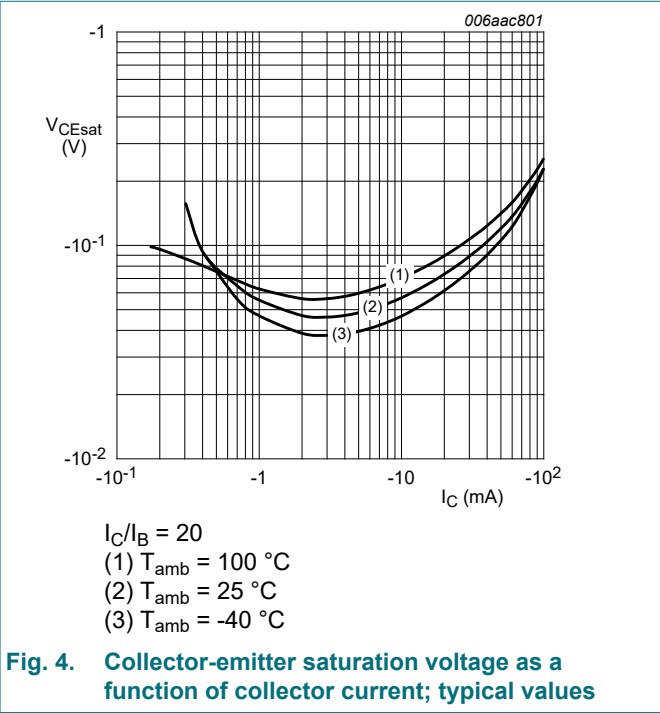
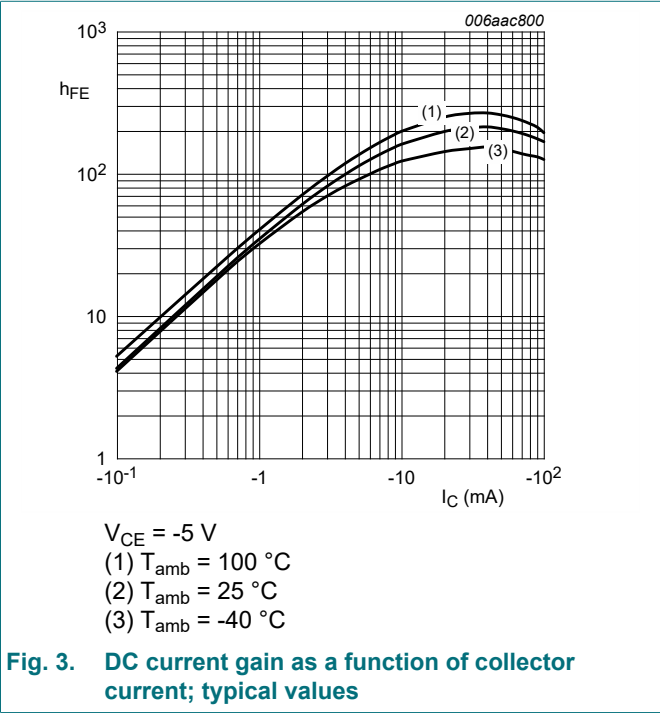

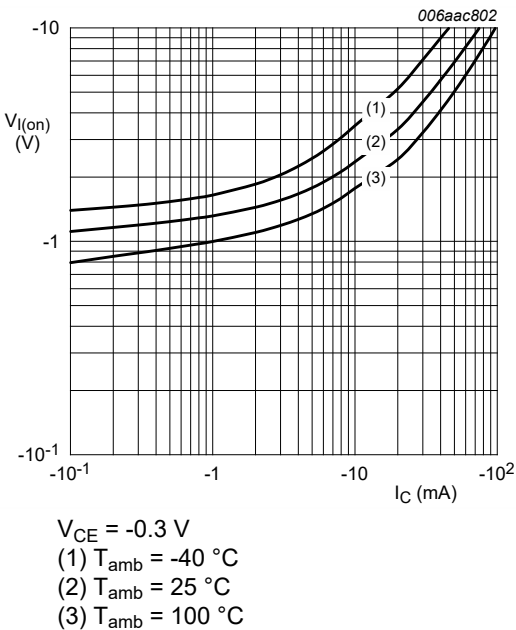


Fig. 5. On-state input voltage as a function of collector current; typical values

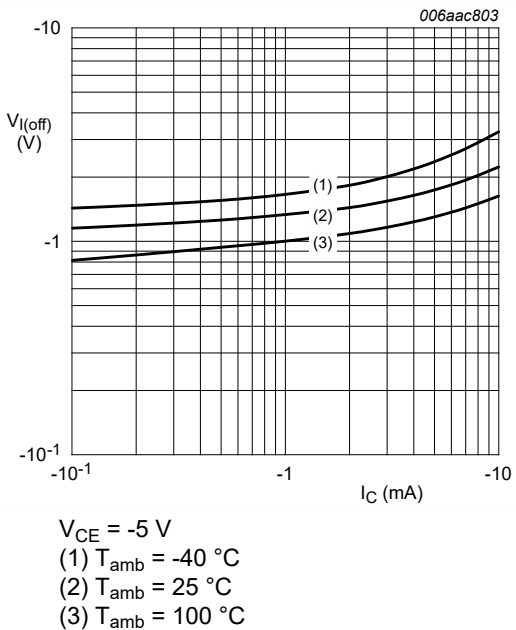


Fig. 6. Off-state input voltage as a function of collector current; typical values

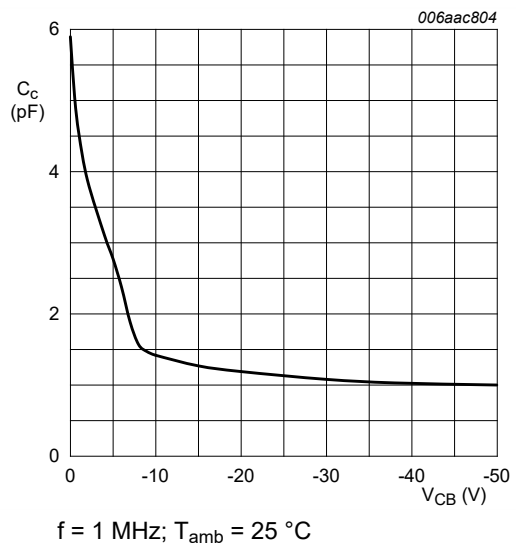


Fig. 7. Collector capacitance as a function of collector-base voltage; typical values

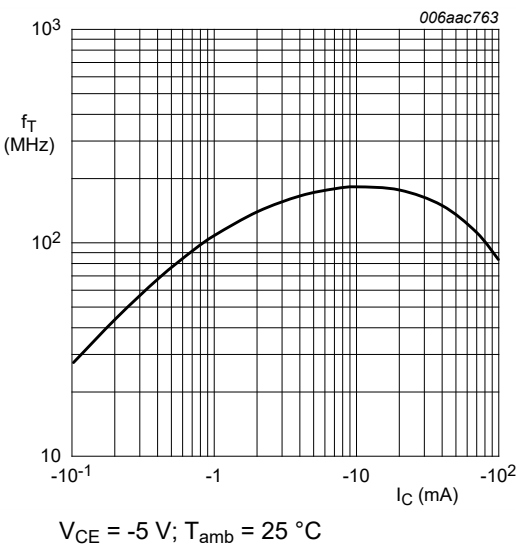


Fig. 8. PNP transistor: Transition frequency as a function of collector current; typical values of built-in transistor

$$R_1 = \frac{V(I_2) - V(I_1)}{I_2 - I_1}$$

- Calculation of bias resistor ratio (R2/R1)

$$\frac{R_2}{R_1} = \frac{V(I_4) - V(I_3)}{R_1 \cdot (I_4 - I_3)} - 1$$

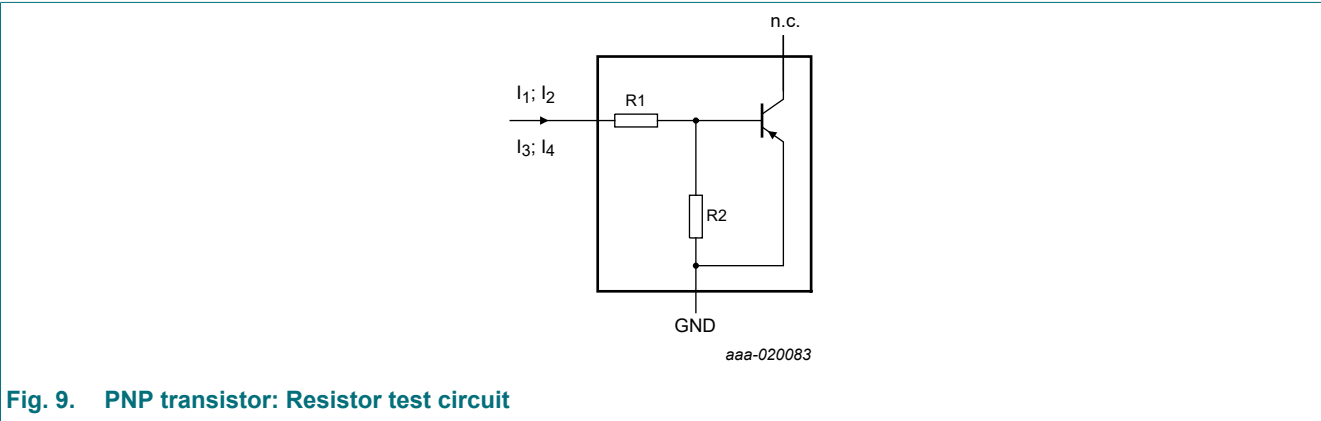


Fig. 9. PNP transistor: Resistor test circuit

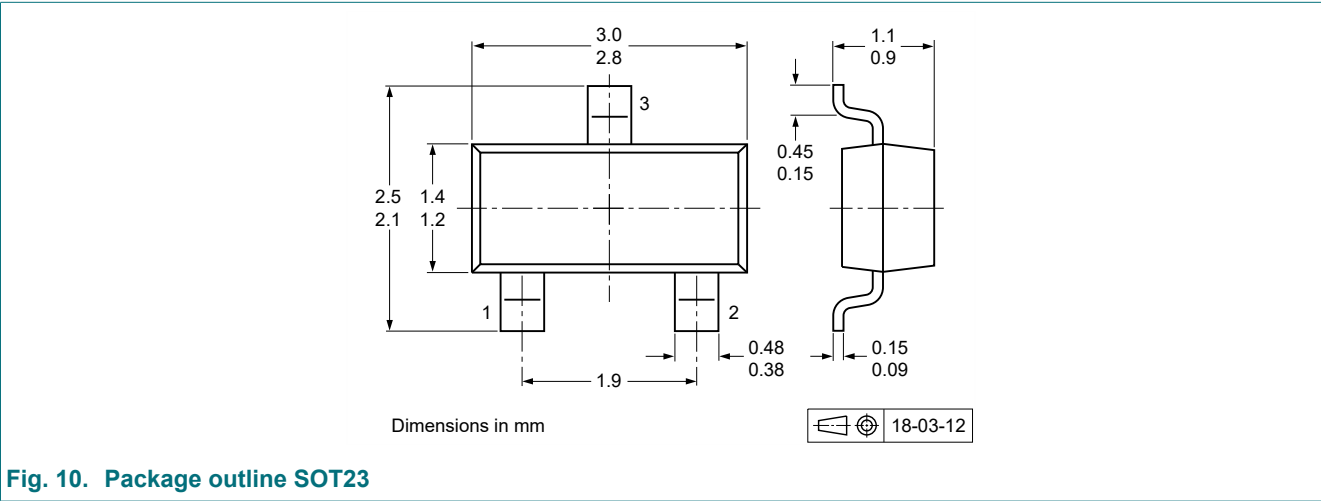
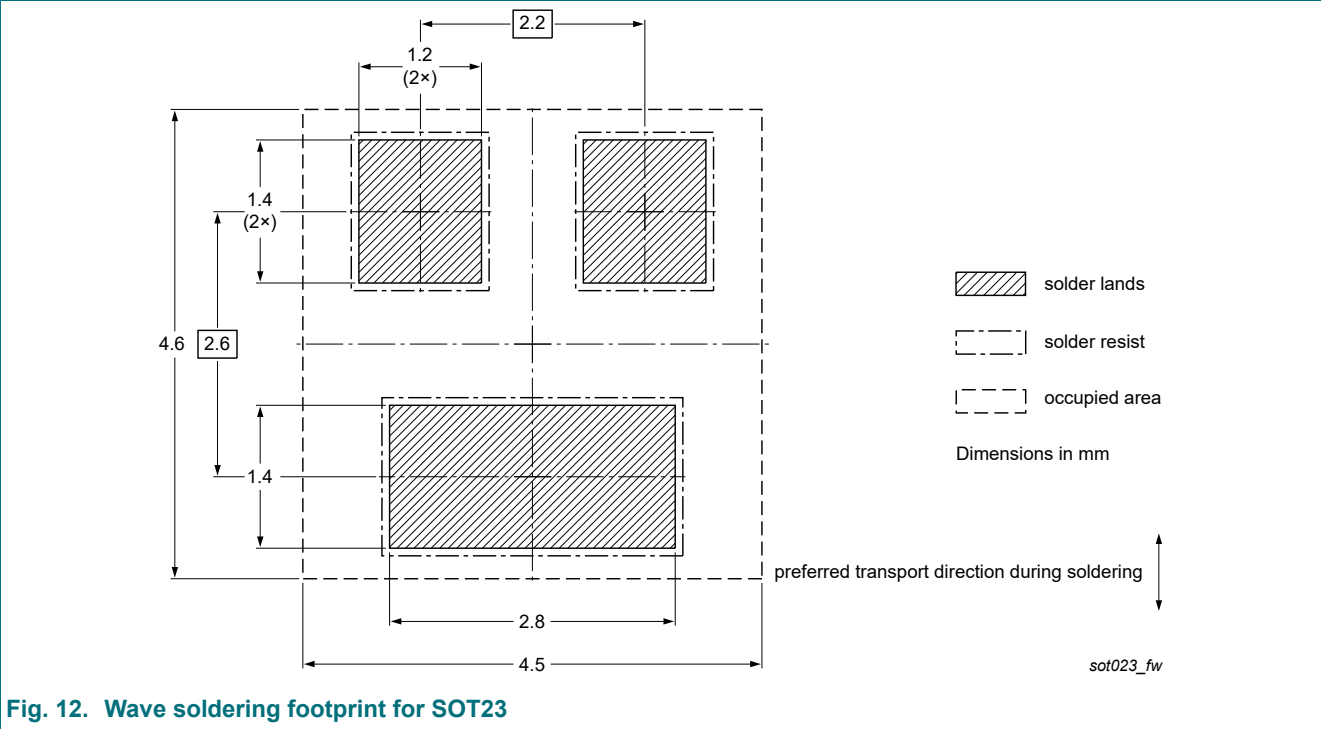
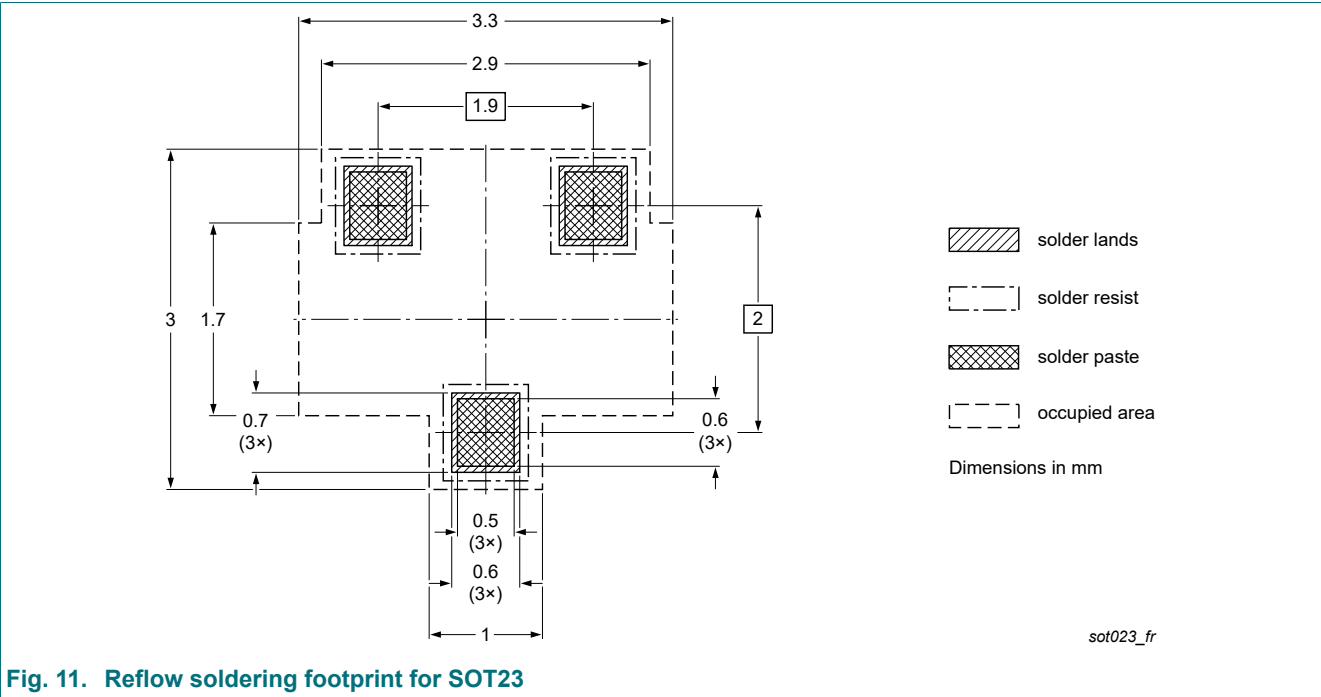


Fig. 10. Package outline SOT23
